(1): The unit value of the 35,443,596 new shares, subject to the capitalization, which will be delivered on October 4, 2013, correspond to the closing price of the SDPromigas shares (Without Dividends) as of August 31, 2013, of which \$100 will be recorded in the capital account and \$4,190 in the "shares placement premium" account, resulting in a total of 1,098,761,972 shares in circulation.

These new shares, like the current SDPromigas type, do not accrue dividends of those declared in March 2013 on the profits of 2012, but do accrue dividends on the profits for the first half of 2013 that will be declared equally for all the valid types of Promigas shares, i.e. Promigas and SDPromigas. Therefore, the transfer of the balances of the shares of the current type of SDPromigas share will be carried out to a cash management account and an ISIN to be defined by the BVC and Deceval respectively at that time, as they included dividends from October 2013. In the next Assembly of March 2014 dividends will be decreed for 100% of the shares in circulation on the profits of the second half of 2013, unifying the two types of currently valid shares and normalizing the payment of dividends on all the shares in circulation.

If fractions result from the distribution of the dividend of shares, the integer value will be taken and in no case will the number of shares to be delivered

be rounded up. Fractions will not be tradable and will be made available to the Assembly for Future Distributions

(2): In accordance with Decree 4766 of December 14, 2011 and Article 2.23.1.1.4 of Decree 2555 of 2012 issued by the Ministry of Finance and Public Credit, if shares are disposed of in the 3 trading days immediately preceding the first date of dividend payment, the pending dividends shall belong to the transferor. The foregoing is without prejudice to Art.3.1.1.12. of the Regulations of the Colombian Stock Exchange, in accordance with supplementary Article 2.23.1.1.5 of Book 23 of Part 2 of Decree 2555 of 2010.

Note: The dividends declared in this distribution project are not comparable with those decreed in March 2013, on the profits of 2012, as in March the profits of 12 months were taken into consideration, and now, in September, 6 months are taken into consideration, because of the change from annual to six-month accounts periods starting this year. We also report that the resources are being distributed as extraordinary dividends, both in shares and cash, from the sale of Promitel and dividends received from Gas Natural de Lima and Callao S.A. - Calidda (these latter items are not a cash inflow).
